Read carefully before filling out the register. This will ensure accuracy.

Write legibly, preferably in ink.

Use the columns indicated by letters.

Forms will be prepared by the Leader of the Neighborhood Association and certified by the President of the District Association to be forwarded to the Bureau of Local Government, city or municipal mayor concerned, and the duplicate returned to the President of the District Association. Exception is made for institutions which shall be filled by the President of the District Association.

The unit of the survey is the family. By head of the family is meant an independent household and by members of the family are meant those who depend upon heads of families; such as, wives, children, and servants living with their families in the household.

Persons who should be considered belonging to an independent household and who are not included in the separate form.

Persons who are meant such relation, as grandmother, wife, daughter, etc.

Persons living in boarding houses, each family living or boarding house or hotel shall be considered as members of the family if the head of the household is the head.

9. In the case of institutions, such as convents, monasteries or dormitories, all those living therein shall be considered as members of a family with the head of such convent, monastery or manager of the dormitory as head of the family.

10. In the case of hospitals, employees, such as nurses, attendants, etc., who do not maintain independent households but are quartered in the hospital shall be considered members of one family with the Director of the hospital as the head.

SPECIFIC:

1. Enter paternal surname first, followed by maternal surname and given name.

2. State relationship to head of family, as grandmother, wife, son, daughter, father, mother, brother, sister, servant, etc.

3. Give age in completed years.

4. Indicate sex by "M" for male and "F" for female.

5. Indicate civil status by "S" for single, "M" for married, "W" for widowed, or "D" for divorced.

6. Birthplace must include barrio or sitio in proper cases.

7. Indicate citizenship, as Filipino, Chinese, etc.

8. Race—Write Yellow, Brown, or White race, etc. Report as "Mixed" if those whose parents are of different races.

9. Enter only the dialect usually spoken in the home, as Tagalog, Bicol, Ilocano, etc.

10. State highest grade completed, 2nd year (college), etc.

11. State whether able to read and write in English; answer "Yes" or "No."

12. Specify occupation, as carpenter, etc. Avoid the term "employee" or any other term in household work or any kind of work unless the person can be considered employed as housekeeper. For those who have no present employment, state their former occupation.

13. Give the nature of business, as cigar factory, importer and exporter, etc.

14-15. State salary or wage, as "monthly."

16. Fill column with "Yes" or "No" if the person is a former resident.

17-18. The columns "Former address" are to be filled by the President of the District Association in the case of those residents who have come to this system.

19. State religion in full, as Catholic, etc. For minor children should be that of their mother, if the same religion, the religion of the mother of the family.

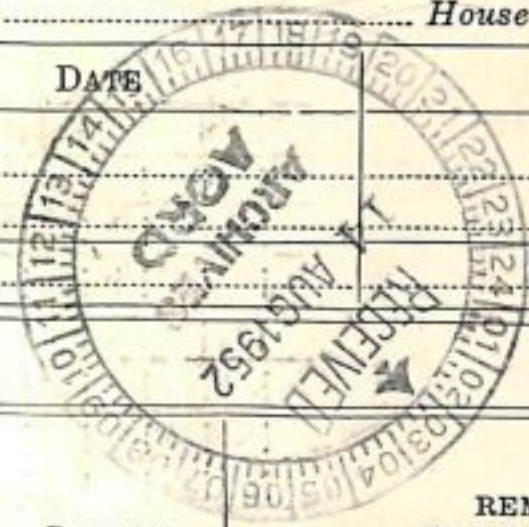
20. In the column "remarks" note any special features, such as transferred after the enforcement of the law, as past police record, education, conduct, etc.
