TO : Commanding Officer, ECLGA.

1. At about 3:00 p.m., yesterday, 28 April, at Malanday, Polo, Bulacan, a carretela owned by Alberto Duenas, while going towards Manila, was struck by PCAU truck driven by S/Sgt. Manuel C. Garcia of PCAU No. 3 San Jose, Nueva Ecija. The accident occurred when Garcia swerved his vehicle to the other side of the road where the carretela was, to pass a truck parked on the road side, as shown in attached sketch.

2. Duenas carretela was completely wrieked.

3. Sgt. Garcia was released after investigation for the reason that the supplies on his truck had to reach San Jose on time.
