TO : CO, ECLGA

1. Regarding the verbal instructions of the Chief of Staff, ECLGA, on April 26th, '45, no action had been found up to the present time. Guards were detailed at Malanday, Banga gasoline station and Kalbarie on the "watch out" towards Lt. Daze's residence.

2. Several complaints reached this Headquarter that there are some civilians that are confiscating rice on the highway. MP guards at Kalbarie investigated. They saw two men armed with Thompson and Garrand and as they approached these men tried to escape. Our Guards went after them and they were found to be CP of Meycauyan. They claimed that that was an order.

3. 1st Lt. Castro, OD, went to the Municipal Mayer to verify everything. The Municipal Mayer said that they are just following Administrative Order No. 2.

4. Waiting for your further instruction so that steps may be taken to CP who may have confiscated rice for their consumption only.

1. At 3:00 PM, yesterday 28th of April, an accident occurred in Malanday, Pele, where one of our MP Guards was detailed. Caretela of Guadalupe Dueñas was heading towards Manila and a truck was parked few meters away on the other side of the road.

2. A PCAU truck driven by S/Sgt. Manuel C. Garcia suddenly appeared and tried to get over the parked truck, accidentally ~~it~~ hit the ~~truck~~ caretela.

3. Those injured were Lolita Pauline and Alberte Dueñas both from Lengas, Meycauayan, Bulacan. They were at once brought to the Base Hospital for treatment.

4. Damage: The caretela was completely wrecked.

5. After a short questioning, S/Sgt. Manuel C. Garcia was released because the truck was loaded with supplies and it had to reach San Jose on time. His Address: PCAU No. 3 stationed at San Jose, Nueva Ecija.

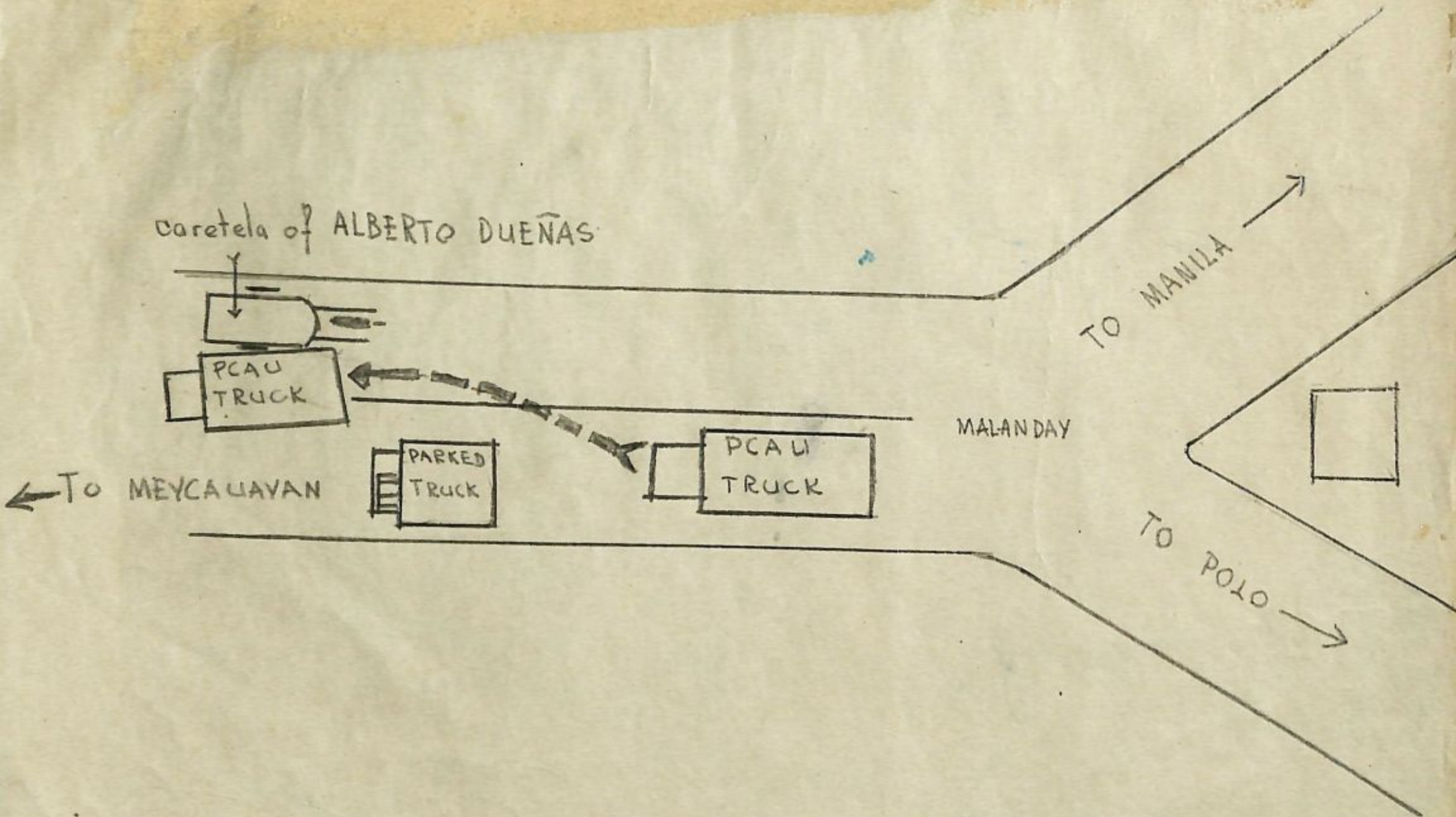
