

#### 5. Advertisement of Undelivered Mail Letters

It has been brought to the attention of this Office that some postmasters do not observe the regulations regarding the advertisement of undelivered mail letters before they are returned to the sender or sent to the Dead Letter Office. In order to avoid complaints from patrons, postmasters should exert efforts to deliver mail matter addressed for delivery at their offices; and if delivery by the letter-carrier fails, the mail matter must be advertised once a week until the expiration of 30 days from the time of its receipt after which it must be returned to the sender or sent to the Dead Letter Office. The list should be posted in a conspicuous place in the post-office lobby and at various public places for the information of the public. All unclaimed matter of the first-class, except post cards, including letters and other matter returned from the Dead Letter Office direct to the sender and valuable packages, should be included in the advertisement of undeliverable matter, with the exception of matter bearing return request; matter addressed to persons who call regularly at the post office; matter indorsed "To be held until called for," "Postal Restante," "General Delivery," and similar directions; and matter which the addressee has requested to be retained. Unclaimable matter should not be included in the aforementioned advertisement. The word "ADVERTISED" and the date of advertising shall be plainly written or stamped on every piece of mail matter advertised upon the address side of it before the mail matter is disposed of. See Section 391 to 393 of the Manual.



In view of the advice recently received from the Postal Administration of China to the effect that parcel post service in Manchuria has been suspended until further notice, parcel post packages addressed for delivery in Manchuria should not be accepted for mailing by postmasters and other postal employees concerned, until otherwise instructed by this Office. Packages, however, addressed for delivery in the leased territory of Kwantung, comprising Chinchow, Choushuitzu, Dairen, Lingchientun, Liushutuh, Pitzuwo, Port Arthur, Pulantien, and Shahokow, may be accepted for mailing as this territory is under the Japanese Postal Administration.
