

RESOLUTION NO. 106

The Mayor presented to the Council in session the letter of the District Engineer, Masbate, dated June 14, 1940, to the Municipal Council of Arroyo, in connection with the application for a loan of this Municipality of P20,000.00, for the construction of the proposed Presidential Building of Arroyo.

After a serious consideration by this Council of the Matter, it was unanimously agreed upon to adopt the Masbate type which is a semi-permanent building, provided that the same should be altered so as to embrace all the different offices of this Municipality, to wit:

1. - That the offices of the Meat Inspector, Municipal Agricultural Inspector, the Sanitary Inspector which at the same time utilized as Public Dispensary and the Post Office shall be housed in the proposed Presidential Building.
2. - That the cells for both sexes must be made more spacious specially the Male's cell which ought to accommodate at least twenty persons.
3. - That the walling of the first story should be made of concrete.
4. - That all the frame work of the building should be of first group timbers.
5. - That in order to accomplish accomodating all offices mentioned above, this Council proposes to have an additional wings of 4.80 M. width by 10.50 M. length on both ends of the main building of the Masbate type, to make the Arroyo type larger by that size inasmuch as the loan applied for this project is sufficient to warrant the construction.

WHEREFORE, this Court hereby finds judgment for the plaintiff and with respect to the three defendants Florentina Clemente, Alvaro Guevara and Francisco Ricafranca to vacate the land which is unlawfully occupied by them within ten (10) days from receipt of judgment, and the other defendants to vacate the said premises within forty (40) days from date hereof, with costs against the said defendants.


