

1. The following organization will be followed in the province of CAPIZ:

(a) The PROVINCE OF CAPIZ is divided into two sectors, viz., AKLAN SECTOR and ILAYAN SECTOR.

(b) The AKLAN SECTOR is divided into three Districts. The First District is composed of the towns of BANGA, CALIVO, NUMANCIA, LIZO, MALIBAO, and LIBACAO. The Second District is composed of the towns of BALBETE, NEW WASHINGTON, ALTAVAS, and BATAN. The third District is composed of the towns of IBAJAY, NAVAS, MAKATO, TANGALAN, and BURUANGA.

(c) The ILAYAN SECTOR is divided into four Districts, to be known as the 4th, 5th, 6th, and 7th Districts. The 4th District is composed of the towns of TAPAZ, LUMALAG, LUMARAO, and DAO. The 5th District is composed of the towns of MAMBUSAO, SAPIAN, SIGMA, and IVISAN. The 6th District is composed of the towns of PANITAN, PONTEVERA, PANAY, and PILAR. The 7th District consists of the town of CAPIZ.

(d) The town of JAMINAN is directly under the jurisdiction of the Military Commander of the Province of Capiz.

2. Each Sector will be under the command of a Sector Commander appointed by the Provincial Commander. Each District is under the command of a District Commander appointed by the Sector Commander subject to the approval of the Provincial Commander. Each Town will be under the command of a Town Officer appointed by the District Commander subject to approval of the Provincial Commander upon recommendation of the Sector Commander.

3. Each Sector Commander will organize a staff consisting of an Executive Officer, an Intelligence Officer, and an Adjutant. He is authorized a Headquarters Company to consist of not more than twenty enlisted men commanded by the Adjutant. The Executive Officer will act as a Supply Officer.

4. District Commanders will organize a similar staff as in par. 3.
