The replacement in man power is being taken care of by the TC, training institution of the battalion. If its faculty is reenforced and if it is supplied with the necessary equipment it will be to serve the Regiment and even the Division.

The immediate replacement of the ammunition used in the recent operations is the imperative need of the battalion at present. As we expect more frequent actions, we need more ammunitions.

B. CASUALTIES:

Killed in action- One officer and one EM.

Died of disease contracted while performing his duty- -None

C. EVACUATION:

As ever it was, the battalion is intact. We feel safe in our present CP.

E. SUPPLY AND EVACUATION ESTABLISHMENTS.

As we foresee the danger of the enemy penetration, a plan to change the CP at least once a month has been approved by this Command. Accordingly the plan to construct a cottage at Tamocol to house our papers and equipment was dropped. The vacant houses in the locality are at present used to house our men, equipments and supplies.

The transfer of equipment and supplies in case of emergency will be a serious handicap if no proper planning is done beforehand in view of the much reduced number of the personnel. If every body does his duty well and sticks to his assignment, all will be well. Good organization and better and timely planning on the part of the CO's will do more than counter balance the reduction of the personnel.

It is therefore expected that the efficiency of the different units will not be much affected by the reduction of their respective personnel except those of the S-4 that are considered too few to meet the needs of the battalion.

F. STATUS OF SUPPLY:

So far the flow of supplies from the fields to the CP's of the different units of this battalion remains steady. The people appear to
