

The President then announced that the term of each and all the members of the Board of Trustees has already expired and that it was then the business of the assembly to elect the five new members to the Board. But before the election he submitted first his annual report as President of the Board of Trustees. He also submitted the report of the Treasurer, Atty. Indovico O. Peralta, for the school or business year 1940-41.

When the discussion on his own report and the report of the Treasurer was over, the President then announced the election. A quorum was declared by the chair and forthwith, the President appointed the Committee on Elections to conduct and supervise the election by the assembly of the members to the Board of Trustees. The said Committee was composed of the following:

- Mrs. Pilar Tumbokon, Member
- Miss Salvacion Mates, "
- Mr. Salvador Sarabia, Secretary.

The election immediately took place and the following persons were voted upon with the number of votes cast in their favor opposite their respective names:

Attorney Salazar, Mr. Prado, Mr. Tolentino, Atty. Laserna, and Atty. L. O. Peralta, being the first five having received the highest number of votes, were proclaimed elected new members of the Board of Trustees by the Committee on Elections, and the official result of the said election, duly certified by each and all the members of the Committee on Elections was furnished the President, the Secretary and the Treasurer of the corporation.

After the election, the President announced that the table was open for further business.

Upon motion of Atty. Indovico Peralta, duly seconded and carried, it was approved to amend Article 33 of the Constitution and By-Laws of the Corporation, so that the same, as amended, may be read as follows:

" Art. 33.- Todos los años en o hacia mediados de Mayo de cada año se hará el balance de dichos fondos. El balance líquido en metálico no se reportará, sino que se clasificara como fondos de reserva."

MEETING OF THE BOARD OF TRUSTEES
Kalibo Institute, Inc.

Held at the Kalibo Institute Building, Inc.
May 30, 1940, at 5:00 P.M.

Mr. Jose L. Pastrana, Director of the School was asked to be present.

The meeting was called to order and presided by President Manuel Laserna.

The President then read the Annual Report of the Director of the School and asked the members to make appropriate steps toward solving the needs and problems of the school embodied in the said report.

The Director of the School also brought to the attention of the Board that he received from the Office of Private Education Administrative Instructions No. 3, s. 1940, dated May 3, 1940, whereby the National Language, or, Tagalog is made a compulsory subject in the course of instruction in the Fourth Year.

And acting upon the recommendation of the Director, it was resolved by the Board to employ a Tagalog Teacher to teach the National Language in the Fourth Year.

Upon motion of Trustee Prado, duly seconded, it was resolved that a new additional teacher will be employed to teach in the school.

It was also resolved, upon motion of Dr. Reyes that the Treasurer be authorized to make disbursements for remodelling the partitions between rooms in the school building and for such other repairs and additional works thereto.

It was likewise resolved upon motion of Trustee Laserna that a "duplicator" valued at not more than One Hundred Twenty Five Pesos (P 125.00) be purchased by the school under installment plan.

Upon motion of Trustee Prado, it was also resolved that the salaries of the Director of the school and the Treasurer of the corporation be increased from Seventy Pesos and Twenty Five Pesos to Seventy Five Pesos and Thirty Pesos respectively, said increase to take effect ~~at~~ the month of June, 1940.

Upon motion of Trustee Prado, it was also resolved that the entrance and library fees be borrowed from the general fund and the same appropriated for the purchase of text-books to be rented to students ; provided, however, that the accountings covering transactions relative to the purchase of books and rentals of the same be separated from that general fund.
