(a) Whenever the Secretary finds that the allotment of any quota, or proration thereof, established for any area pursuant to the provisions of this Act, is necessary to assure an orderly and adequate flow of sugar in the channels of interstate or foreign commerce, or to prevent disorderly marketing or importation of sugar, or to maintain a continuous and stable supply of sugar, or to afford all interested persons an equitable opportunity to market sugar within any area's quota, after such hearing and upon such notice as he may by regulations prescribe, he shall make allotments of such quota or proration thereof by allotting to persons who market or import sugar, for such periods as he may designate, the quantities of sugar which each such person may market in continental United States, the Territory of Hawaii, or Puerto Rico, or may import or bring into continental United States, for consumption therein. To avoid disturbing changes in established business practices, allotments shall be made in such manner and in such amounts as to provide a fair, efficient, and equitable distribution of such quota or proration thereof, by taking into consideration the processings of sugar from sugar beets or sugarcane to which proportionate shares, determined pursuant to the provisions of subsection (b) of section 302, pertained; the past marketing or importations of each such person; or the ability of such person to market or import that portion of such quota or proration thereof allotted to him. When establishing marketing allotments for any year, the Secretary shall first allot to each person an allotment sufficient to enable such person to market the entire year-end carry-over inventory produced from the previous crop and the balance shall then be allotted in accordance with the above provisions. The Secretary may also, upon such hearing and notice as he may by regulations prescribe, revise or amend any such allotment upon the same basis as the initial allotment was made.

(b) An appeal may be taken, in the manner hereinafter provided, from any decision making such allotments, or revision thereof, to the United States Court of Appeals for the District of Columbia, the decision of which court shall be final, in any of the following cases:

(1) By any applicant for an allotment whose application shall have been denied.

(2) By any person aggrieved by reason of any decision of the Secretary granting or revising any allotment made to him.

(c) Such appeal shall be taken by filing with said court within twenty days after the decision complained of is effective, notice in writing of said appeal and statement of the reasons therefor, together with proof of service of a true copy of said notice and statement upon the Se-

(3) For sugar, derived from sugarcane and testing more than ninety-two sugar degrees by the polariscope, by multiplying the number of pounds thereof by the figure obtained by adding to 0.93 the result of multiplying 0.0175 by the number of degrees and fractions of a degree of polarization above ninety-two degrees;

(4) For sugar and liquid sugar, testing less than ninety-two sugar degrees by the polariscope, by dividing the number of pounds of the "total sugar content" thereof by 0.972.

(5) The Secretary shall establish rates for translating sugar and liquid sugar into terms of raw value for (a) any grade or type of sugar or liquid sugar not provided for in the foregoing and (b) any special grade or type of sugar liquid sugar for which he determines that the raw value cannot be measured adequately under the provisions of paragraphs (1) to (4), inclusive, of this subsection (g).

(h) The term "total sugar content" means the sum of the sucrose (Glucose) and reducing or invert sugars contained in any grade or type of sugar or liquid sugar.

(i) The term "quota," depending upon the context, means (1) that quantity of sugar or liquid sugar which may be brought or imported into the continental United States, for consumption therein, during any calendar year, from the Territory of Hawaii, Puerto Rico, the Virgin Islands, the Commonwealth of the Philippine Islands, or a foreign country or group of foreign countries; (2) that quantity of sugar or liquid sugar produced from sugar beets or sugarcane grown in the continental United States which, during any calendar year, may be shipped, transported, or marketed in interstate commerce, or in competition with sugar or liquid sugar shipped, transported, or marketed in interstate or foreign commerce.

(j) The term "producer" means a person who is the legal owner, at the time of harvest or abandonment, of a portion or all of a crop of sugar beets or sugarcane grown on a farm for the extraction of sugar or liquid sugar.

(k) The terms "including" and "include" shall not be deemed to exclude anything not mentioned but otherwise within the meaning of the term defined.

(l) The term "Secretary" means the Secretary of Agriculture.

TABLE II - QUOTA PROVISIONS

Sec. 201. (a) The Secretary shall determine for each calendar year the amount of sugar needed to meet the actual requirements of consumers in the United States, which determination shall be made during the month of December for the succeeding calendar year. The Secretary shall determine from the official statistics of the Department of Agriculture the actual consumption of the United States during the twelve-month period ending October 31st next preceding the calendar year for which the determination is being made, and an amount of sugar equal to such consumption shall be made available to the consumers of the United States during the succeeding calendar year by means of
