1. Wound lacerated, scalp, frontal, irregular V-shaped, 5 cm. long, 1/2 cm. deep - 7 days
2. Fracture, ulna, complete, simple left, - 30 days healing.
3. Fracture, humerus, left, healing time 30 days.
4. Bruises, forehead; eyebrow, left; legs and knees; left and right; buttocks, left; thigh, left; forearm and arm, left; back, lumbar region - 5 days healing.
5. Contusions, arm, left - 4 days healing.

The healing of these wounds are so assumed if no infection sets in.




