MANIFIESTO

A todos los Plantadores de Cañadulce de Filipinas

Salud:

Los plantadores de Negros Occidental, miembros de las Asociaciones afiliadas a la Confederación de Asociaciones y Plantadores de Cañadulce, reunidos en asamblea magna en Bacolod el 28 de Junio del presente año, adoptaron los siguientes acuerdos: 1.º pedir que se eleve la participación de los plantadores a 60% de su cosecha, contra 40% de las centrales azucareras, y 2.º pedir que plantadores y centrales participen en la misma proporción de 60% y 40%, respectivamente, en los gastos por abono.

No necesito encarecer la justicia y la necesidad de esta petición. Es justa, porque por ella los plantadores no reclaman mas que lo que de justicia corresponde a su trabajo y a su esfuerzo, tan inequitativamente retribuidos con el tipo actual de la distribución de la cosecha. Y es necesaria, porque si no se concede el aumento pedido, los plantadores de cañadulce, no derivando utilidad alguna de su trabajo, antes por el contrario, viéndose cada día más y más hundidos en deudas y obligaciones, no tardaran en renunciar a la imposible empresa, y buscar en otros negocios mejor fortuna. No es preciso decir la suerte que cabría a la industria azucarera del país.

Basándose en datos aceptados por la Philippine Sugar Association, organización constituida principalmente por las Compañías propietarias de centrales azucareras, el costo medio de producción por pico de azúcar para el plantador de Negros Occidental es de P8.00, mientras que el costo de producción por pico para la central oscila entre P3.00 y P4.00. Al precio actual de P7.50 por pico, mientras el plantador pierde un 12.5% del dinero que invierte en la producción, la central gana de 100% a 150% de su capital de operación. Verdad es que el costo de producción varía para el plantador, según las condiciones de trabajo de cada localidad, pero es igualmente cierto que donde el costo de producción baja, alguien sale sacrificado: si no es el plantador, es el obrero o el inquilino o kasamá.

Si, como parecen presagiar todos los indicios, el mercado del azúcar en el mundo se mantiene a su presente nivel por varios años, tal vez por tiempo indefinido, debido al bajo costo de producción que puede lograrse en algunos de los más grandes países azucareros del mundo, bajo el tipo actual de reparto de la cosecha en Filipinas, la industria azucarera, estará condenada a una muerte segura y total. Pero no es sólo la duración indefinida o más o menos prolongada de los actuales precios ruinosos del azúcar lo que ha de acarrear su ruina. La misma flagrante falta de equidad de los contratos existentes vicia de muerte la industria, porque cuando al ánimo del plantador llegue la persuasión de que él, invirtiendo más dinero y poniendo mucho mayor esfuerzo, no es mas que un esclavo de empresas que ponen menos capital en la industria, y cuyos accionistas no realizan el más mínimo trabajo, se creará un estado de descontento y de protesta que condenará a la industria azucarera a perpetua inestabilidad, y causará su gradual extinción.

Los plantadores de Negros han tomado la iniciativa en esta demanda de justicia. Pero ellos solos no bastan. Es preciso que los plantadores de cañadulce de todas partes de Filipinas se unan al movimiento, expresando su adhesión al mismo, y dando, por su cuenta, los pasos que sean necesarios para hacerlo triunfar pronto y decisivamente. Es preciso que las compañías centralistas vean que todos los plantadores de Filipinas, como un solo hombre, demandan una participación en el fruto de su trabajo, que les permita no ya prosperar, sino siquiera vivir. Es preciso que el pueblo y el Gobierno de las islas se convenzan de que este movimiento no es sólo obra de unos cuantos agitadores como alegan los que se obstinan en negarnos justicia, sino que es de todos los esforzados hombres del campo que labran la tierra para producir cañadulce, y que si se retiran del campo porque la vida se les hace imposible, no habría industria azucarera en Filipinas.

Si, como esperamos, los plantadores de su distrito aprueban nuestra petición, nos permitimos invirtarles a que hagan constar su aprobación formalmente en resoluciones o escritos al efecto, ya sea colectivamente, por medio de sus respectivos asociaciones, ya individualmente. En el caso de que no exista Asociación de Plantadores en ese distrito, nos tomamos la libertad de sugerir que se organicen en Asociación, con el fin de facilitar cualquier programa de acción que nosotros nos tracemos en defensa de nuestros comunes intereses.



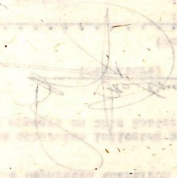


