BIRTH CERTIFICATE REQUIREMENT FOR  
ENROLMENT, GRADE ONE

To Supervising Teachers:

The Director of Education by 5th indorsement dated March 31, 1933, requested that paragraph 10 of Division Memo. # 48, s. 1931 be either rescinded or suspended. Parts of the referred to indorsement are as follows:

" . . . any regulation requiring parents to produce birth certificates costing them \$0.40 more or less is unjust . . . . .  
It will be unnecessary to question a parent's statement relative to the birth of their children, except when the size and apparent immaturity of the child gives reasonable cause for such questioning."

In accordance with the above, birth certificates should NOT be required for grade one children; except when there is apparent reason for doubting the age of a child as represented by the parents or guardian.
