The undersigned accuses Orlando Caluy, Hinto of, Kabanisan, Balabán, Cebu
(Name of defendant) (Address)
of a violation of section 2751 of Act No. 2711 as amended, of the Philippine Legislature, committed as follows: 8 11 106 5915

That on or about August, 1939, in the sitio of Tinago
Barrio of Kabanisan, Municipality of Balabán
Province of Cebu, Philippines and within the jurisdiction of this
Court, the said accused, without lawful authority, did then and there wilfully and criminally clear,
with the purpose of making cañgin, approximately 1.00 hectares of the public forest, and
as a result thereof 21.45 cubic meters of logs, groups 84.00 on 1, 4th gro p. 11 bar
growing therein were destroyed, the double government charges on such forest products so unlaw-
fully destroyed being 179.10 pesos (P 179.10).
(Amount equivalent to twice the regular forest charges)
