The under-parts are ashy brown. The forehead is chestnut and the rest of the upper-parts are steel blue. Like the swift the swallow flies about after insects. Some swallows build nests shaped like a bottle, others build nests shaped like a new moon, and others dig holes in trees. The eggs are white with brown spots.

CARABAO BIRD (Talon or talabong)

The commonest and the smallest of the several herons found in the Philippines is the carabao bird. Its length is about 55 centimeters. It has a yellowish head, a yellow bill and wine-colored plumes. The legs are long. The nests are located in tall grass. The eggs are the color of the blue sky. The carabao bird feeds on insects, lizards, and snakes.

UNIT VI - THE EARTH AND THE SEA

A volcano throws out lava, ashes, pieces of solid rocks, and gases. Sometimes the eruption of a volcano takes place with great force and with a roar that can be heard more than a hundred kilometers away. Great clouds of dust and ashes remain in the air for months, at times shutting off the sunlight.

Mountains have been formed by the flow of lava from volcanoes. Years and years ago terrible eruptions took place. This occurred time after time. Finally, mountains of different sizes were formed. Hills and mountains were formed in other ways.

Two-thirds of the surface of the earth is water. Fish and certain water plants live in the sea. Fish live in the sea just as people live on land. There are plants under the sea just as there are trees, shrubs, and grass on land.

The rising and falling of the water in the ocean or sea is called the tide. Have you ever observed a falling tide? The water rises and falls twice a day, and so there are two high tides and two low tides daily.

Brooks and large rivers carry much soil all along their way. Swift rivers even carry stones and sand. When the speed of the river is checked, the stones fall to the bottom first, then the sand, and last the light-colored soil called sediment. The brooks give us beauty.

NOTICE OF CONSOLIDATED ACCOUNT OF TAXES

Sir:

You are hereby notified that, pursuant to the provisions of Act 4181, approved on December 7, 1931, the existing forfeiture on your property under tax declaration No. 11849 of the municipality of Tuburan, province of Cebu, has since been revised and your property assessed to you and that the total or unpaid taxes and penalties due on said property in the amount of 8.40 may be paid in ten equal installments beginning with the year 1932, each installment in the amount of 8.40, to be payable at the same time and in the same manner and proportion as the regular tax, subject to the following conditions:

1. The current annual tax or the installments in-advance shall be paid before they become delinquent. Otherwise, the property will be forfeited, although the next payments of the annual installments of the consolidated account may have been kept-up-to-date; once forfeited, the property may be disposed of in accordance with the provisions of Act 3965 (Sec. 6, Act 4181)
2. Failure to pay two annual installments of the consolidated account shall be sufficient cause for the Provincial Treasurer to declare the automatic reassessment of the real property, and the same shall be again alienable under Act 3965, (Sec. 4, Act 4181)
3. In case of reassessment of real property for failure to make payments of two annual installments of the consolidated account or of the taxes for any year subsequent to 1931 as above provided, no portion of the payments previously made shall be refunded and all such payments shall be forfeited to the Government. (Sec. 7, Act 4181)
4. Any or all annual installments of the consolidated account may be paid in advance with a discount of 15 per centum on the amount paid in advance. Advance payment means the payment made during the year of any annual installment or installments of the consolidated account not yet due. (Sec. 8, Act 4181)
