Subject: Report on robbery and threatening to kill the undersigned;  
To : The Provost Officer  
Curuan, Zamboanga

1. Last Dec. 28, -1943 I went to a patrol for food to tingultingulan. The following morning I went to Muti for the same purpose. On account that Moros of this place were denying that they have no supply at all for the Army, I went to the extreme of searching the house of Jalus (Moro). When I arrived to the house of the said Moro I ask for permission if I could get up in their house. A woman and a man gave me the permission to get up. When I was up in the house I asked them if there a some palay for voluntary contribution or for sale. They respond that they have none at all. I told them I am not going to get any grain without paying the quantity I'll get. But still they refused me. Under the house there were Hips of palay so that I was made to suspect that this house has plenty of palay. So I asked there permission to take a look inside the house. The people in the house gave me the permission concerning this matter. Before getting in side the sala of the house I called for the man to accompany me in verifying if it's true that there in no palay.

2. When I was inside the sala of the house the very fellow I called to accompany went to a bad intention in grabbing a barong under the mat. Luckily I was on guard so that I got him. At once I took a look under the mat. I found two barong without scabbard, one barong under a law a bench and one spear by the side of the wall. I took hold of this arm and continue my mission. I saw six big bayones with two cavans of palay every bayon and five small bayones. So I asked them why they were denying of not having palay at all. When I finished I went down and proceed home.

3. On my way my soldiers saw the very fellow who accompany in searching the house run with two trunks from the neighbor house. I sent my soldier and the guide to call for the fellow who took the trunks. But he escape leaving the trunks in the bushes, open with clothings.

4. I took the trunks with me to the house of Jose Ocampo where I investigated matters. I sent for the Jalus (Moro) and arranged the matter. After the arrangement he gave me voluntarily two punch and one shirt. I return one barong and the spear to him and took with me two barong. I turned over the barong to the Company.

5. By guidance of the above report the undersigned request for the arrest of Alipin (Moro) and call him for investigation concerning this matter he had done.

6. Attached receipt of the clothing that Jalus (Moro) gave the undersigned. For verification this clothing are now in the hands of the soldiers who accompany me.
