TRAINING LESSONS IN SILENT READING.

Stone Classification Silent Reading Lessons as:

1. Content lessons - in which the teacher's primary purpose is the realization of the content values of a unit of material, in relation to the general aims of establishing permanent reading interests and developing appreciation, providing varied reading-experiences, and inculcating high ideals.
2. Training lessons - in which the primary purpose is to secure improvement in some particular phase of reading ability.
3. Test lessons - in which the primary purpose is to measure the pupil's ability.

In a content lesson- the method must serve the content and be adopted to its organization. The training or test lesson, we construct and adopt our material to serve the training or test objective.

Specific Training Objectives:

1. To increase rate of continuous reading, as a story or book,
 - A. Phrase flashing to increase the length of the unit of recognition.
 - B. Reading under time pressure.
 1. One plan might be- Allow class five minutes for S.R. Pupil counts number of pages or lines, and records on slips of paper. Teacher calls upon child who read smallest amount to reproduce what he read. Then the pupil next in amount read continues the reproduction, and so on through the class.
 2. Choose a longer unit. Formulate a question for each page. Allow pupils to read until one or two have finished the unit. Pupils record number of pages read. Call on pupils from lowest to highest asking questions arranged in the order of the pages.
 - C. Timing pupils reading.
(Any exercise in speeding up rate should be accompanied by the comprehension check)
 - D. Time record on outside reading.
Assign long unit of easy material. Pupil checks rate and reports to teacher. Comprehension. Comprehension is checked through discussion.
 - E. Skimming- This method is legitimate in glancing through newspapers, and getting facts from reference books.

II. Training in the three phases of comprehension, speed, accuracy and depth.

A. Speed of Comprehension

Phrase Game

Teacher writes on board a set of questions, which can be answered by phrases in the reading lesson. They are exposed and recovered quickly one at a time, while pupils search in reader for answering phrases.

Ex. Question- Where did the princess live?

Answer- In a beautiful castle.
